RAMP UP Grant Received

We are excited to announce that the agency received formal approval notification for the Indiana Housing & Community Development Authority's (IHCDA) RAMP UP grant! RAMP UP provides grants to not-for-profits for the installation of exterior ramps to homes occupied by individuals who need to improve accessibility of their homes. These ramps can accommodate a broad range of physical needs, increase safety, reduce falling risks, and help individuals maintain their independence.

Terri Poynter, Weatherization Program Manager, and Ralph Blankenship, Weatherization Building Technician, have been working on the grant application, securing donations, and finding eligible clients for several months. They will be partnering with Servants At Work (SAWs), a non-profit volunteer organization whose main mission is



the construction of ramps, to complete the work on the initial 10 homes. The agency hopes to continue writing for the grant for as long as funds are available. There is currently a lengthy waitlist; however, continued referrals are encouraged. If you have clients that could benefit from this service, please refer them to <u>tpoynter@capwi.org</u>.

Bi-Annual Inspections Completed



February 29th was an unusually busy day for the Housing Division staff. All worked together, under the direction of Angela Golia, Property Manager, to conduct the biannual inspections on all agency-owned rental properties. Staff were divided into teams to cover properties throughout the six-county service area. Each unit/home was

inspected for damage and general maintenance. Furnace filters and smoke detector batteries were replaced by the visiting staff, and a sticker of emergency contact numbers was placed on the refrigerators. These inspections help to assure that tenants are maintaining healthy and safe living environments, provide staff a chance to check on general maintenance issues, and assist to prevent property damage or misuse. These have been a great step in assuring that our rental properties are in good condition.

WIC's Little Library

Our Vermillion County WIC office and United Way partnered to have a Little Library installed in the WIC waiting room. On top of ensuring health and proper nutrition for their clients, WIC is promoting early literacy while they wait for their appointment!
